RECOMMENDED ACTION

That Council ratify the purchase for the Cisco Voice Over Internet Protocol (VOIP) phone system upgrade, licensing, and implementation services to Logicalis, Inc., not-to-exceed the amount of \$125,000.00, and authorize the Town Manager or designee to execute appropriate agreements and documentation.

BACKGROUND

On March 21, 2020, the Town Manager issued Proclamation No. 2020-01 proclaiming the existence of a local emergency relating to the worldwide spread of respiratory illness due to the novel coronavirus known as COVID-19. On March 24, 2020, the Town Council adopted Resolution No. 2020-10, ratifying Proclamation No. 2020-01 and declaring a local emergency.

As with nearly every other agency around the world, technology came to the forefront of operations. The Department of Innovation and Technology (IT) began supporting a remote workforce, in addition to adapting other Town operations that typically required a physical presence. IT deployed approximately 25 laptops to staff with remote access to Town resources for telecommuting purposes; implemented online payments for additional Town systems such as Permits and Code Enforcement; developed an online Community Access geographic information system (GIS) with locations of 'open' businesses and further implemented remote communication tools such as Zoom and Microsoft Teams.

The Town's phone system was originally implemented over 10 years ago and has been out of support for nearly 5 years. With the COVID-19 pandemic, there is an important and

increased need for remote meeting capabilities such as teleconferencing. Likewise, with the increased number of remote workers since March 2020, there is a need for adequate telecommuting capabilities including the functionality for staff to access their Town phone line remotely.

This purchase will upgrade the core hardware and software for the Town's phone system, providing much needed and improved functionality that will better support telecommuting and teleconferencing abilities. New features to the Town will enable remote connections to the phone system, allowing staff to place/receive calls while remote working as if they were at their desk. During the upgrade process, substantial improvements to system configurations will be performed to improve the over-all call quality and experience for both internal and external callers. This purchase will also replace 15 phones that are no longer supported with the new system.

This purchase is authorized under the Town Manager's authority under the Town's Municipal Code section 3.12.270(3). Under this provision the Town Manager may authorize the purchase of materials, supplies, equipment and services in an emergency situation when it is determined that services impacting the public health, safety or welfare would be interrupted if the normal purchasing procedures were followed. Here, the emergency purchase of the phone system upgrade and implementation services allowed for the Town to take advantage of CARES Act funding for the project, thereby lessening the impact on the Town's general fund, which may now be used to positively impact the public health, safety, and welfare. All emergency purchases must be submitted to the Town Council for ratification at the next Council meeting after the purchases were authorized. Emergency purchases are not limited to \$50,000.00 as are open market purchases or informal bids.

FISCAL IMPACT

This purchase will be funded in combination from the Town's PEG Channel Fund (25%), Wastewater Fund (25%), and the CARES Act Coronavirus Relief Fund (CRF) for CITIES and TOWNS (50%), with a 1:1 match as required. The CRF is a new funding program provided by San Bernardino County (SBC) for infrastructure projects After a complete review of the Town's application for this project, the County of San Bernardino Board of Supervisors has approved funding as provided under the CARES Act Spending Plan approved by the Board of Supervisors. This purchase uses the NASPO ValuePoint Master Agreement #AR233 (14-19), Cisco Participating Addendum CA #7-14-70-04 contract. There is no impact to the General Fund.
