RECOMMENDED ACTION

It is recommended that the Town of Apple Community Development Citizen Advisory Committee (CDCAC):

- A. Conduct a public hearing and upon accepting public comment, actively engage in the careful consideration of intentionally providing funding recommendations of no more than \$89,496 for public service activities for inclusion in the Town's 2021-2022 Community Development Block Grant (CDBG) Annual Action Plan.
- B. Provide a recommendation for staff to allocate funds on behalf of CDCAC should the projected CDBG annual allocation increase or decrease.
- C. Approve the increase of the minimum subrecipient award for public service activities under the Town's CDBG program from \$4,000 to \$10,000.

BACKGROUND

The U.S. Department of Housing and Urban Development (HUD) mandates that all entitlement communities receiving Community Development Block Grant (CDBG) funds prepare and submit a Consolidated Plan every five years to establish a unified, strategic. vision for housing and community development actions, to ensure compliance with the Consolidated Plan, the Town is required to submit an Action Plan each year. The Action Plan will appropriate CDBG and Home Consortium funds for the upcoming 2021- 2022 program year, in accordance with the CDBG program national objectives, the goal of the Action Plan is to serve the Town's low-and moderate-income residents, eliminate slum and/or blight, and meet other urgent community needs. the funding recommendations of the CDCAC must be consistent with the Town's 2017-2021 Consolidated Plan.

in preparation of the Action Plan and to encourage community and citizen participation, a Notice of Funding Availability (NOFA) was published in the Valleywide Newspaper on January 1, 2021 in English and Spanish. Notifications were also emailed to interested parties and previous applicants. in addition, electronic copies of the application were made available on the Town's website. Applicants were required to attend a mandatory NOFA Workshop on January 7, 2021 to allow Town staff the opportunity to explain the application process and answer any questions the agencies may have. Applications were due on February 11, 2021 by 4:30 p.m. applicants were allowed to submit their applications by mail, hand delivery, or email submission. No late applications were accepted.

ANALYSIS

The Town received a total of eight (8) applications for public service activities. Each agency who applied for funding was awarded funds during the current 2020-2021 program year. Staff has completed its review of the applications and has determined that all applications have meet the eligibility and national objective requirements of the CDBG program.

As of the date of this public hearing, HUD has not released the 2021-2022 CDBG Entitlement allocations. For this reason, the Town has been instructed to proceed with allocating funds based on the amount received during the 2020-2021 program year of \$596,645 and adjust those funding recommendations accordingly once the final allocations have been disseminated. Under HUD regulations found at 24 CFR 570, each entitlement grantee may allocate a maximum of 15% of its annual allocation (\$89,496) to public service activities. According to current Town policy, a subrecipient grant award cannot be less than \$4,000. However, during the Town's most recent HUD monitoring, staff was encouraged to increase the minimum award to a subrecipient under the CDBG program to no less than \$10,000 due to the administrative burden required of the agencies.

FISCAL IMPACT

the Town is an entitlement community under the CDBG program. As an entitlement community, the Town is allocated CDBG funds on an annual basis. The Town anticipates receiving approximately \$596,645 in CDBG funds during the 2021-2022 program year. the CDCAC's funding recommendations for public service activities will be included in the Town's Draft 2021-2022 Annual Action Plan for public review and comment of no less than 30-days at which point the Draft 2021-2022 Annual Action Plan will be brought before the Town Council for approval. The Town Council's approval of the CDCAC's funding recommendations will result in the adoption of the funding recommendations into the Town's 2021-2022 Annual Action Plan and the Town's Housing and Community Development Department's 2021-2022 CDBG Budget.
