3. CDBG/ GRANT UPDATE

Parks and Recreation Manager, David Coleman updated the commission on Mendel Park restroom and that the engineering portion is complete, and we are waiting for the official stamped plans so we can put it out to bid for installation.

The Camera project is being delayed due to unforeseen concerns about upgrades needed on the building. The bid was delayed but is expected to go out to bid again soon.

David advised the commission of the Prop 68 grant and the park projects that we have submitted. The commission received a general image with details on what was submitted to California State Parks. He also advised the commission of the Prop 68 Per Capita grant and a few projects we are thinking about submitting, such as the Splash Pad and Roofing at James Woody Community Center. He also advised the commission of the Orchard Tree Grant that is being finalized soon.

4. QUIMBY FUND UPDATE

Parks and Recreation Manager, David Coleman updated the commission on the Quimby Fund balance of \$980,000 with an estimated 300k additional each year due to development fees as the town grows. We will have an exact figure once we have received the audited balance amount.

PARK AND RECREATION COMMISSIONER COMMENTS

Commissioner Doran asked about the retention basin at James Woody Park and wanted to confirm that the turf will be replaced when the drainage project is completed. Dave advised that the turf will be installed once the project is complete in April.

Commissioner Smith discussed the pickleball Zoom meeting she attended was well received and she is playing pickleball the next day. Vice-Chair Tarango advised he also received a lot of input on the Pahute Park meeting.

PARK AND RECREATION MANAGER'S REPORT

Parks & Recreation Manager, David Coleman advised the commission of the St. Paddy's Day Run that was hosted and we are opening the pool on May 29th with new flooring that is being installed throughout the Aquatic Center. The department is planning a full schedule of events and programming that will be back to normal again this Summer.

David advised the commission that we are installing MUSCO at James Woody and explained the positive impact for the User Groups. The shade structure at Civic Center Park is on track to be delivered and installed in June along with tables, trash receptacles, and barbeque grills.

David also advised the commission of the Exo-Cage installation at Brewster, James Woody, and Thunderbird Parks and the need for a ribbon cutting video.

RECOMMENDED ACTION:

Approve using up to \$500k of Quimby funds for the water well project at Horsemen's Center Park.

SUMMARY:

The current well, which is over 1-mile from the park, was built in the 70's and after many repairs, has finally failed. Staff determined that it would be better to locate a new well on park grounds. Staff commissioned a hydrogeological study to find the best location for a well on Town owned property.

The completed hydrogeological report for Horsemen's Center Park has identified the most ideal area within park boundaries for a well to produce up to 100 gallons per minute. Staff has prepared an RFP to attract bids for this project. We expect bids to fall in the \$400-\$500K range.
