CALL TO ORDER:

Vice-Chairman Doran called the meeting of the Park and Recreation Commission of the Town of Apple Valley to order at 6:04 p.m. in the Town Council Chambers.

OPENING CEREMONIES

PLEDGE OF ALLEGIANCE: The Pledge of Allegiance was led by Commissioner Tatera.

PRESENTATIONS: Parks & Recreation Supervisor, Andy Shoup presented on a proposed expansion of the Aquatic Center. The proposal included a splash pad project in which he provided several options including budget amounts, photos, and several options provided by Cousilman Hunsaker.

PUBLIC COMMENTS

Ronald Kent Espolt – Discussed the desire to start a model air plane program for the youth.

Gary Childress – Discussed his desire to bring lifetime sports to the town of Apple Valley.

STAFF REPORTS

1. APPROVAL OF MEETING MINUTES

Commissioner Wilson motioned to approve the Regular Meeting Minutes for February 3, 2022, and Commissioner Tatera seconded the motion.

3. CDBG/GRANTS UPDATE

Parks and Recreation Manager, David Coleman, notified the commission that the equipment has been purchased and will be installed by town staff.

Park Playground project – Hoping to work with Sourcewell to assist with the new playground projects.

Prop 68 – Pahute Park lease is at AVUSD and will be going to their board meeting on April 14th to get approved. Once we receive the approved lease agreement, we will begin the process of providing an official RFP and get the landscape architect to provide the concept art and assistance with amenities.

The project should be completed by the December 2024. We should have an update each meeting on this project.

Per Capita grant – Will provide new fencing and a new restroom near field 5 at James Woody Community Center.

4. QUIMBY FUND UPDATE

David Coleman, Parks and Recreation Manager discussed the well at Horsemens Center Park. He advised the commission that we have an approved water meter to change the well site to run municipal water to Horsemens Center. There is additional research they have to do prior to the project but he is expecting less cost than originally thought.

He also informed the commission that there will be a report going to the Town Council the following Tuesday regarding the Hilltop House. We will be changing the original allotted amount of 169k to only 75k to accomplish the project. He will wait to discuss any further until the Council meeting.

Dave also advised the commission of the backyard sports area at Civic Center Park, the kiosk for the CCP Pavilion, and the design for the proposed splash pad at the Aquatic Center.

PARK AND RECREATION COMMISSIONER COMMENTS

Commissioner Nunez-Franco advised the commission that he would like to suggest commissioners visit parks that they do not normally attend to get ideas on new amenities and possible improvements as well.

PARK AND RECREATION MANAGER'S REPORT

David Coleman, Parks & Recreation Manager advised the commission of the park tour with two of the commissioners. He would like to encourage the commissioners to do the park tours when available. Also, he discussed the department staff are working on amenities, such as water bottle filling stations, solar powered lights, etc.

Dave advised of the new staff and the possibility of changing responsibilities throughout the department.

SUGGESTED ITEMS FOR FUTURE AGENDAS

Commissioner Nunez- Franco requested the commissioners to take 2 parks each and advise the commission of improvements that can be made.

Commissioner Tatera would like an update on the following items:

- Non potable water at the Apple Valley Golf Course

- Putting green at Civic Center Park
- He would like to know if the current Development infrastructure funds keeping up with inflation.
- He would also like to include the topics the public speakers requested.

Commissioner Wilson would like an update on James Woody Park projects.

SUMMARY:

Parks and Recreation have three Development Impact Fees that are separated out to build and improve recreational facilities and amenities. There is not an identified automated Consumer Price Index percentage adjustment but can be adjusted by approval of the Council.

Aquatic Center Facilities

A separate development impact fee is collected to defray the cost of expanding the aquatic center to meet the demands of growing population created by the construction of additional residential dwelling units.

0.103 square feet of pool surface per person is what is used to determine the size of combined pools in aquatic facilities.

The impact fee for each detached dwelling is \$98. It has risen 23% since 2005.

Public Use Facilities (Community Centers)

A separate development impact fee is collected to defray the cost of expanding the community centers to meet the demands of growing population created by the construction of additional residential dwelling units.

0.347 square feet of facility space per person is used to determine the size of community centers.

The impact fee for each detached dwelling is \$305. It has risen 23% since 2005.

Parkland Acquisition and Recreation Development

A separate development impact fee is collected to defray the cost of expanding the our park system to meet the demands of growing population created by the construction of additional residential dwelling units.

3 acres of park land per 1000 population is the standard goal for parkland.

The impact fee for each detached dwelling is \$3873. It has risen 28% since 2005.
