PORTABLE SIGNS (EXTENSION OF TIME TO DISPLAY TEMPORARY SIGNS)		
Summary Statement:		
To assist local business owners during the current economic downturn, staff is requesting that the Town Council extend the period of time businesses have to display portable signs. The "Portable Sign Agreement" was previously offered by the Town Manager to local businesses, in January 2009, for period not to exceed six (6) months. Each business is allowed one (1) portable sign, when in conformance with the "Portable Sign Agreement". Typically, these types of signs are otherwise prohibited, as specified in the Development Code.		
The businesses owners who have received approval of Portable Sign permits will be notified by staff of this extension and that the January 2010 deadline will be the final extension given. The "Portable Sign Agreement" form is available at the Planning Division and is attached to this report.

Move to receive and file the report and to initiate an extension of the Portable Sign permits to January 15, 2010.
