REGULAR MEETING MINUTES – July 28, 2009

OPENING CEREMONIES

CALL TO ORDER:

Mayor Roelle called to order the meeting of the Apple Valley Town Council at 6:30 p.m.

TOWN COUNCIL/REDEVELOPMENT AGENCY CLOSED SESSION

1. Closed Session

MOTION

Motion by Councilman Sagona, seconded by Councilwoman Coleman, and unanimously carried to discuss Closed Session at the end of the meeting.

BUSINESS RETENTION - CHAMBER OF COMMERCE

Pat Orr, Apple Valley Chamber of Commerce, provided an update to the Town Council on upcoming Chamber activities.

PUBLIC COMMENTS

Chuck Hanson, Apple Valley, expressed concern regarding the number of incomplete housing projects in Apple Valley. He questioned the need to support another project.

Pat Hanson, Apple Valley, expressed concern regarding the funding being awarded to Housing Partners, Incorporated for a Senior Housing Project.

Daniel Seagondollar, Apple Valley, recommended purchasing existing housing for rehabilitation instead of building new project during this downward trend in the housing market.

Paul Bruneau, Apple Valley, expressed concern regarding the amount of funding being spent on this project. He spoke of the existing vacancy rate in Apple Valley and stated that he could not support this interest free loan to this organization.

lan Bryant, Apple Valley, expressed concern regarding the approved senior housing project. He spoke of the cost of the project and the approximate selling price of each unit.

Barbara Davisson, Apple Valley, reiterated the statements made by the previous speakers regarding this issue.

Priscilla Ruiz, Apple Valley, spoke on the need for a bicycle park that would ensure the safety of the children in Apple Valley.

Christina Estella, Apple Valley, expressed concern regarding the need for a bicycle park in Apple Valley.

William Furmage, Apple Valley, expressed concern regarding the lack of a bicycle park in Apple Valley. He asked that the skate park be used jointly as a bicycle park.

Salvador Ortiz, Apple Valley, expressed concern regarding the harassment that he believes he has received from the Apple Valley Fire Protection District. He asked for assistance from the Town Council.

COUNCILMEMBER COMMENTS AND COMMITTEE/COMMISSION PARTICIPATION

Councilwoman Coleman commented on her attendance at a Southern California Associated Governments. She spoke of several of the projects proposed by SCAG. She also commented on her attendance at the Mountain Desert League of California Cities meeting.

Councilman Sagona is requesting staff provide information regarding the cost of the annual dues for membership in SCAG.

Councilman Sagona thanked the Town Council for allowing the presentation by Housing Partners. He expressed concern regarding the amount of senior housing already located in the Town and recommended that the Town Attorney provide information to the Council regarding the history of any suits filed by the State of California against a municipality due to lack of required housing.

Mayor Pro Tem Nassif commented on the Mountain Desert League of California Cities Meeting. He spoke of the discussions that were held regarding a proposed trauma center.

Mayor Pro Tem Nassif also commented on the benefit of being a member of Southern California Associated Governments and the use of redevelopment funds.

Mayor Roelle commented on the Yucca Loma Bridge project and explained that some of the money used for this project comes from redevelopment funds.

He also commented that he is in support of the senior housing project.

TOWN COUNCIL ANNOUNCEMENTS

Suggested items for next agenda:

Councilman Sagona requested, with the consensus of the Town Council, that an item be placed on a future agenda to have staff provide a plan, program and/or project that could be developed and enforced by the Town Council to assist those properties that are in great need of improvements using redevelopment funds.

Councilman Sagona also requested that staff provide the Town Council with exit options and strategies for the approved Owner Participation Agreement with Housing Partners, Inc.

It was noted by the Town Attorney that this item could only be reconsidered if a member of the Town Council who voted in favor of the item made the motion to reconsider the item. There being no member wishing to reconsider, the item requested by Councilman Sagona did not move forward.

Councilman Sagona also reiterated his earlier request of the Town Attorney to provide a written memorandum to the Town Council regarding the history of any suits brought forth by the State of California against any municipality or other entity as a result of not meeting the required housing numbers as requested by the State.
