PUBLIC COMMENTS

Chuck Hanson, Apple Valley, reminded the Town Council of the upcoming bike ride. Mr. Hanson requested an update from the Town Council on the bike park.

William Furmage, Apple Valley, recommended to the Council that the bike park be added to the Agenda for a vote instead of a fund raiser. He also commented on the need for concrete to be used at the bike park and the need for more signs at James Woody.

Salvador Ortiz-Lopez, Apple Valley, expressed concern regarding the high taxes for his properties. He respectfully requested assistance from the Town Council on this matter.

Pat Hanson, Apple Valley, expressed concern regarding the proposed ball park and feels the citizens should have the opportunity to vote on this type of a project.

Dino DeFazio, Apple Valley, expressed concern regarding the climate action plan and Terra Nova. He stated that he would request records for information regarding Terra Nova and also requested an update on the multi-species plan.

Richard Simpson, Apple Valley, expressed concern regarding the proposed ball park. He feels too much money is being asked of the tax payers. He also spoke in support of a bike park in Apple Valley.

Kyana Rampley, representing the Girl Scout troops, thanked the Council for their support.

COUNCILMEMBER COMMENTS AND COMMITTEE/COMMISSION PARTICIPATION

Councilwoman Coleman provided an update to the Town Council regarding a new program that Edison is providing regarding educating small businesses on how to save energy. She stated that there will be more events held in the future in support of the program.

Councilwoman Coleman commented on her attendance at the Village Merchant's group meeting and spoke of the discussions held regarding the assessment. She also stated that she attended a Southern California Associated Governments meeting and commented on the projects that were discussed.

Councilwoman Coleman announced that the bike park project would be on the agenda for the meeting of September 22.

Councilman Sagona stated that he is scheduled to attend two meetings with Victor Valley Wastewater Reclamation Authority (VVWRA) where the topics of discussion will include the Joint Powers agreement as well as the Sewer Service agreement.

Councilman Sagona shared an article with the Town Council regarding redevelopment funds. He expressed concern regarding the amount of debt the Town would face if the Town pursues the stadium project.

Councilman Sagona also requested an update from the Town Manger regarding the contributions made to the redevelopment project.

Mayor Pro Tem Nassif stated that he attended the bone morrow donor drive in memory of KayDance Johnson who succumbed to Leukemia. He also commented on the Victor Valley Museum and stated that he would like to see members of the Council and staff work together with the museum to develop a good business plan. He also responded to comments made by the Council regarding the stadium project.

Mayor Roelle commented on his attendance at the Hispanic Chamber of Commerce.
