ADOPT RESOLUTION 2009-46, APPROVING THE DISSOLVING OF IMPROVEMENT AREA NO. 2 OF THE TOWN OF APPLE VALLEY COMMUNITY FACITIES DISTRICT NO. 2006-03 (SKY HAVEN RANCH/GRANITE HILLS)

Summary Statement:

In July 2006 Town Council approved the formation of Community Facilities District 2006-03 to provide a funding mechanism for the payment of development impact fees to the Town of Apple Valley and for the payment of school mitigation fees to the Apple Valley School District. Bonds for this Community Facilities District were never issued and ultimately the project was taken over by the FDIC.

The project was purchased by another developer and that developer has petitioned the Town of Apple Valley and the Apple Valley School District to dissolve the CFD associated with the development. The Apple Valley School District has agreed to remove the Community Facilities District and has recorded the removal with the County Auditor/Controller.

Staff recommends the approval of the petition as requested by the developer. All fees associated with the project will be paid to the Town upon issuance of the certificate of occupancy for each single family home. There is no fiscal impact to the Town by approval of the Resolution.

WHEREAS, the City Council (the "Council") of the Town of Apple Valley (the "Town") has heretofore formed Town of Apple Valley Community Facilities District No. 2006-3 (Sky Haven Ranch/Granite Hills) (the "District") pursuant to the Mello-Roos Community Facilities Act of 1982, as amended, (the "Act"); and

WHEREAS, the Council has received a petition from the landowner of Improvement Area No. 2 of the District requesting the Town to institute proceedings to dissolve Improvement Area No. 2 of the District;

NOW THEREFORE, BE IT RESOLVED BY THE TOWN COUNCIL OF THE TOWN OF APPLE VALLEY, AS FOLLOWS:

Section 1. The Council hereby dissolves Improvement Area No. 2 of the District and discharges the special tax liens on properties within Improvement Area No. 2 of the District. The Town Clerk is hereby directed to record an amendment to a Notice of Special Tax Lien discharging the special tax liens on such properties.
