Town of Apple Valley Dakota Road CDBG-R Grant Award Description

The project includes reconstructing and widening an existing paved, two-lane, 24' wide street with 14' graded shoulders to 44' wide paved street with 4' wide graded shoulders. The additional pavement width will provide two through travel lanes, one continuous left turn lane and two 4' wide, Class II bike lanes. The limits of the project, which are within the CDBG boundaries, are from State Route Highway 18 to Waalew Road, approximately 2.8 miles in length. CDBG-R monies will fund a portion of the project that lies within our low-income service areas.

The Corwin Road project has been in the design phase for the past 2 years. It is anticipated that the project will be advertized for construction in June 2009, awarded in July with construction commencing in August 2009. The Project should take 6-8 weeks to construct, therefore the completion date is estimated to be sometime in October 2009.

Description of Jobs Created

Road graders, road compactors, asphalt concrete paving equipment operators, truck drivers, asphalt manufacturing personnel, engineers, surveyors, geotechnical professionals, supervisors, and inspectors.
