Qualifications for the position: Members are recommended by the Town Manager and approved by the Town Council. Members should be qualified by experience and training in one or more areas related to traffic safety, road design or related matters; high priority and selection considered for persons licensed or certified in engineering, construction and related fields/professions; when feasible, selections considered from (1) California Highway Patrol, (2) Town's Law Enforcement Agency, (3) California Department of Transportation, (4) Automobile Club of California (or comparable company), (5) Apple Valley Unified School District, (6) Town's Public Works Department, and (7) Citizen at large.

Terms of office for Committee members shall be four (4) years, and there shall be no limit on the number of terms any committee member shall serve. (The term of any regular member will be automatically extended pending the qualification of his successor).
