FEE WAIVER REQUEST FOR AN AMENDMENT TO A CONDITIONAL USE PERMIT FOR THE CHURCH FOR WHOSOEVER (18628 SENECA ROAD)

Summary Statement:

Charles Douglas, on behalf of The Church for Whosoever, is requesting a fee waiver to amend the original Conditional Use Permit (CUP) granted to the church to allow for an emergency shelter for homeless persons to be operated as an ancillary use of the church. The total amount of the permit fee waiver is \$2,548. The amendment to the CUP will be reviewed by the Planning Commission at a public hearing on a date to be determined.

Pastor Royce Beserra, from the Church for Whosoever, participated in the recent workshops, hosted by the Town, to discuss the need for homeless shelters in Apple Valley. It was during these discussions that Pastor Beserra voiced his interest in developing a shelter on the church property. Emergency shelters are permitted as an ancillary use to a church, provided that the CUP is amended to include said use. Other locations where shelters are permitted within the Town require a Special Use Permit and the fees are automatically waived. Waiving the fees for the church would be consistent with the regulations for these other locations in Town. The shelter would be open to all those in the community.

Recommended Action:

For good cause shown, and finding a waiver will serve a public purpose and is consistent with similar applications of the Development Code, approve the waiver of amendment to the Conditional Use Permit for the Church for Whosoever.
