ACCEPTANCE OF WORK, NOTICE OF COMPLETION AND RELEASE OF RETENTION FOR THE TOWN OF APPLE VALLEY PUBLIC WORKS FACILITY

Summary Statement:

On June 8, 2010, the Town awarded contracts to the first seven (7) prime contractors for construction of the Town of Apple Valley Public Works Facility. The remaining trades were further evaluated and the next seventeen (17) trades were awarded contracts on July 13, 2010. The remaining seven (7) trades were re-bid and contracts were awarded on September 14, 2010.

Seventeen (17) prime contractors have satisfactorily completed their work and their work has been accepted by the Town (list attached). Additional prime contractors have work yet to be completed or have their work accepted by the Town. Those will be brought to the Council at a later date.

- 3. Direct the Finance Director to release retained funds 30 days after the filing of the Notice of Completion, or notify prime contractors escrow account holders to release the withheld retention funds provided no claims are filed against the contractor or Town.
