BUSINESS OF THE COUNCIL

16. Happy Trails Villas Update

Emily Wong, Assistant Director of Economic and Community Development, presented the staff report as filed with the Town Clerk.

Mayor Pro Tem Stanton asked a series of questions regarding the status of the units, the cost of the units, and whether or not the units will be sold as low income property.

Barry Ephriam, AVHTV, explained the progress that has taken place on the Happy Trail Villas project and the marketing efforts that they will entail once the construction loan becomes final. He spoke about the aesthetics around the project and the benefits that they will give residents. He also stated that he is working with Apple Valley Ranchos to resolve the issues dealing with the water main.

Council Member Roelle asked the Town's recourse if this project is not successful and does not move forward.

John Brown, Town Attorney, recommended that the Town Council should not feel that there is a breach of contract at this time. However, by the next Town Council meeting, he will be ready to respond to the Town Council with a course of action should this project not proceed.

David Mueller, highdesertpolitics.org, presented a timeline that he prepared on the Happy Trail Villas project. He also presented what he believed were violations to the project.

Mayor Pro Tem Stanton requested that staff come back to the Council at the next meeting with information regarding disability access regulations for the project.
