DISCUSSION REGARDING SPEAKING TIME LIMITS FOR PUBLIC COMMENTS DURING TOWN COUNCIL MEETINGS

Summary Statement:

At the Town Council Meeting on December 13, 2011, Mayor Stanton suggested that an item be placed on a future agenda for the purpose of discussing the speaking time limits during public comments.

On January 9, 2007, amendments were made to the Town Council Rules of Procedure based on recommendations and concerns expressed by the Town Council. These amendments included setting the time limit for public comments to three (3) minutes. Before this change was implemented, staff researched time limitations for public comments which are attached (and have been updated) to this report. Based on these findings, staff recommended that the time limit for public comments be changed to three (3) minutes. This change continued to allow all speakers to be heard during the public comment portion of a meeting and the Town Council upon consensus has the authority to grant additional time to a speaker if needed.

This item will be presented by Mayor Stanton and will provide for the opportunity to present suggestions and/or receive input regarding the subject matter.
