This Notice is formal notification that the Planning Director will make a decision on June 24, 2026 regarding the following application:

CASE NUMBER:	Site Plan Review (SPR) 2022-002
PROPERTY OWNER:	Green Trucking Solutions, LLC
AGENT:	Maria Estrada
PROPOSAL:	A request to construct a 354,000 square foot cold storage logistics and warehouse building on an 18.8-acre parcel (APN 0463-231-06)
ENVIRONMENTAL DETERMINATION:	A Subsequent Initial Study was completed in accordance with Guidelines for Implementing the California Environmental Quality Act (CEQA). The Subsequent Initial Study was undertaken for the purpose of deciding whether the project may have a significant adverse effect on the environment and reflects the independent judgment of the Town as Lead Agency. The Subsequent Initial Study was prepared and tiered from the “Town of Apple Valley Environmental Impact Report (SCH 2008091077), Apple Valley General Plan and Annexations 2008-001 and 2008-002” (August 2009). Based on the Subsequent Initial Study, the Town concluded that the project, with mitigation measures applied, will not have a significant adverse effect on the environment and has, therefore, prepared a Mitigated Negative Declaration (SCH No. 2023080221).
LOCATION:	Northwest corner of Navajo Road & Lafayette Street, in the North Apple Valley Industrial Specific Plan (NAVISP), I-SP Industrial-designation.

Any interested party may present information which may be of assistance to the Planning Department on this proposal and environmental determination.
